# **Declaration of an Interim Alcohol Protected Area**

I, Philip John Timney, the Director of Liquor Licensing pursuant to section 170A(5) of the *Liquor Act 2019* (the Act) and with reference to section 8 of the *Interpretation Act 1978*, declare each area specified in the Schedule to be an interim alcohol protected area in which liquor is prohibited for the period commencing on 5 October 2022 and ending on 16 July 2024.

Note

Section 170B of the Liquor Act 2019 includes an offence for doing certain things in interim alcohol protected areas.

## **Schedule**

# 1 Baygida

All of that parcel of land within the East Arnhem locality in the Northern Territory of Australia, being that part of NT Portion 1647 known as Yabooma Island and occupied by the community known as Baygida, being administrative parcel NT Portion 8004(A) and extending to the Low Water Mark of that island.

#### 2 Dhipirrinjurra

All of that parcel of land and seas within the East Arnhem locality in the Northern Territory of Australia, containing an area of 12.56 hectares more

or less, being that part of NT Portion 1646 designated NT Portion 8006(A) and contained within a circle of radius 200 metres centred at Map Grid of Australia 1994 (Zone 53) coordinates 510 617 Easting (metres) and 8 645 972 Northing (metres).

Note the subject Interim Alcohol Protected Area excludes any areas of land subject to a Land Use Agreement pursuant to section 19 of the Aboriginal Land Rights (Northern Territory) Act 1976 (Cth).

# 3 Garanydjirr

All that parcel of land near the community Garanydjirr in the Northern Territory of Australia, being that part of NT Portion 1646 designated NT Portion 8010(A), and bounded by lines described as follows:

Commencing at the intersection of the meridian of East Longitude 135 degrees 1 minute 4 seconds with the top of northern or left bank of Glyde River; then northerly by the said meridian to intersect with parallel South 12 degrees 16 minutes 20 seconds; then generally south easterly to the intersection of the parallel South 12 degrees 16 minutes 38 seconds with the top of western or left bank of Glyde River; then generally south westerly to the intersection of the meridian of East Longitude 135 degrees 01 minutes 18 seconds with the top of northern or left bank of Glyde River; then generally westerly along the northern or left bank of Glyde River to the point of commencement.

# 4 Kewulyi

All that parcel of land being within NT Portion 4777 plan(s) S95/218A known as Kewulyi.

#### 5 Moorongga

All that parcel of land within the East Arnhem locality in the Northern Territory of Australia, being that part of NT Portion 1647 known as Moorongga Island and occupied by the community known as Moorongga, being administrative parcel NT Portion 8005 (A) and extending to the Low Water Mark of that island.
